**Associate Dean for Experiential Education (July 2014 - present):** Responsible for administration of the entire clinical education program, including four live client clinics, clinical externships for academic credit, and a mandatory *pro bona* legal work requirement. Position includes all responsibilities of the previous Director of Clinical Programs position, held from August 2000 until July 2014. Promoted from Assistant Dean to Associate Dean in 2022.

**Director of Criminal Defense Clinic (August 1995 - June 2010, January 2014 - present):** Direct and supervise the Roger Williams University Criminal Defense Clinic, a one-semester program in which second and third year law students represent indigent criminal defendants in Rhode Island District Court and Rhode Island Traffic Tribunal. Handle an annual case load of approximately 150 cases per year.

**Professor of Law (August 1994 - present):** Teach various doctrinal and skills courses including criminal law, criminal procedure, interviewing and counseling, trial advocacy, and legal research and writing. Promoted from Assistant Professor to Associate Professor in 1997. Granted tenure in 2000. Promoted from Associate Professor to Professor in 2005.

**Associate Dean for Academic Affairs (July 2010 - June 2013):** Oversaw academic administration of the School of Law, including all issues regarding faculty and students. Responsible for hiring and supervision of adjunct and visiting faculty.

**Distinguished Service Professor of Law (August 2008 - July 2010):** Honorary appointment bestowed by the Dean of the School of Law in recognition of outstanding service to the community both within and outside of the School of Law.
