Boim v. Holy Land Found. for Relief & Dev., 549 F.3d 685, 698 (7th Cir. 2008) (holding that Anti-Terrorism Act allowed suit by victims against entity that allegedly provided funding to Hamas and knew of Hamas's history of violence against civilians).

East Bay Sanctuary Covenant v. Trump, 950 F.3d 1242 (9th Cir. 2020) (affirming preliminary injunction against Department of Homeland Security (DHS) rule that denied asylum to persons who entered United States at other than officially designated points).

East Bay Sanctuary Covenant v. Barr, 964 F.3d 832 (9th Cir. 2020) (affirming injunction against DHS rule that denied asylum to foreign nationals who failed to apply for asylum in third country, such as Mexico, that they traveled through en route to United States).
