





Rhode Island Sea Grant Law Fellow Program

What is the Law Fellow Program?

- The Sea Grant Law Fellow Program provides answers to marine law and policy questions by matching law students with requests from constituent groups.
- The Law Fellow Program is supported by Rhode Island Sea Grant.
- The Law Fellow Program is housed at the Marine Affairs Institute at the Roger Williams University School of Law, in Bristol, RI, in partnership with Rhode Island Sea Grant and the University of Rhode Island.

Who are Law Fellows and what do they do?

- Law Fellows are qualified law students with an interest in marine law, and excellent writing and research skills.
- Law Fellows respond to requests by government, nonprofit and private industry marine organizations for legal research and analysis on marine law and policy questions (see reverse for examples of projects).
- Law Fellows cannot provide legal advice or become involved in litigation.
- Law Fellows are paid, supervised, and dedicate 10 to 15 hours per week each semester to their assigned project.

How are projects selected and administered?

- The Legal Program's Staff Attorney works with the requesting organization to identify appropriate marine law research topics suitable for Law Fellows.
- The Staff Attorney selects qualified students, matches them with projects, oversees each student's work, and is the point of contact for outside organizations.
- Typically, a one semester project involving one Law Fellow costs the requesting organization \$3,000, which includes student wages, supervision by the staff attorney, and access to complete legal research resources.
- Projects are typically one semester long with one Law Fellow assigned per project, however, projects can last longer and utilize more than one Law Fellow.
- The final work product is typically a memorandum but can also involve oral presentations or other dissemination of the Law Fellow's work as appropriate.
